

# **Practical information** about REVA2025

### 24, 25 AND 26 APRIL 2025, FLANDERS EXPO GHENT

After a one-off edition in December 2023, we will be organising our exhibition regularly in the spring of every uneven-numbered year from 2025 onwards.

### **PARTICIPATION WITH NO HASSLE**

Want to experience an easy participation with no fuss? Our team of experienced staff will do everything in their power to make your participation in REVA completely hassle-free.

### **REGISTRATION DATES IN THREE PHASES**

To ensure every exhibitor can hire the surface area they want and to puzzle together all the stands suitably, we will be accepting registrations in three phases this year.

### Phase 1 - 13/05 onwards - for stands of 72 m<sup>2</sup> or more

- Who is this for? Exhibitors who had a stand of 72 m<sup>2</sup> or more at REVA2023. Or for REVA2023 exhibitors who want to expand their stand to 72 m<sup>2</sup> or more.
- > Every exhibitor will get the opportunity to confirm the place that they had at REVA2023.
- **)** Do you want a bigger stand than the one you had at REVA2023? Or would you like to move your stand to a different position? We will consider the possibilities with you.

### Phase 2 - 27/05 onwards - for stands of 48 m<sup>2</sup> or more

- Who is this for? All REVA2023 exhibitors who had a stand of 48 m<sup>2</sup> or more at REVA2023 or want to expand their stand to 48 m<sup>2</sup> or more.
- > You can choose your position freely, subject to availability.

### Phase 3 - 12/06 onwards, 9:00 AM - for all prospective exhibitors

- > Who is this for? All prospective exhibitors, irrespective of the size of their stand or history with REVA.
- Please note: bear in mind the minimum surface areas for exhibitors with no commercial activities (6 m²) and those with commercial activities (9 m²).





### **HOW TO CHOOSE A STAND?**

You can choose between several different sizes of stand. You are obviously welcome to combine a variety of different stands. Please indicate your preferred location and the desired size using the form on the website.

You will receive a provisional stand confirmation after you register. Sometimes, changes are unavoidable for organisational reasons. It goes without saying that we will contact you in the event of any such changes.

In the event that there is more than one candidate for the same location, priority will be given based on the registration time (first come, first served).

Only associations with no commercial activity can reserve an **all-instand** van 6 m<sup>2</sup> reserveren (zie verder). Natuurlijk kunnen die ook voor een grotere plek kiezen op de beurs.

Do you offer products and services for **blind and visually impaired** people, do you work in the **tourist sector** or do you want space for your **government body** at REVA? If so, you will be eligible for space in one of the zones reserved for these exhibitors. Find out more in this brochure, in the 'Themes at REVA' section.

The plan shows two small, interconnected squares at regular intervals. These are the places where **water and power connections** are possible. Please take this into account when choosing your spot and setting up your stand, especially if you are combining multiple stands.

















# **Hire costs** and discounts

The cost of hiring your stand depends on the products and/or services that your company or association will be offering at the exhibition. There are four categories with corresponding rates.

### 1. BASIC PRICE: EXHIBITORS WITH COMMERCIAL ACTIVITIES: €121/M2 (HORS TVA)

- > Price excludes file charge for registration fee, administration and promotion costs: €220 (excl VAT)
- > For stands with **increased visibility** (3 or 4 open sides and a depth of 8m = 'front stand'), a surcharge of €7.00/m² applies.

### POSSIBLE DISCOUNTS FOR THESE STANDS

### **REGISTER BEFORE 1 NOVEMBER 2024**

If you do so, you will benefit from a discount of €5/m² on the price of €121/m², as long as you pay a deposit of 30% in autumn 2024. You will receive an invoice for this deposit.

### HIRE A STAND LARGER THAN 80 M2

If you do so, you will benefit from a discount of €15/m² on the basic price of €121m² from the 81st metre onwards.

### 2. PRICE FOR EXHIBITORS WITHOUT COMMERCIAL ACTIVITIES: €52/M2 (HORS TVA)

- > Price excludes file charge for registration fee, administration and promotion costs: €110 (excl VAT)
- > For stands with **increased visibility** (3 or 4 open sides and a depth of 8m = 'front stand'), a surcharge of €7.00/m² applies.

If you do not supply any paid services or sell/hire any products, if you are mainly based on voluntary work or you are a government body, the rate for exhibitors without commercial activities will apply to you.

This rate applies to interest groups, self-help groups, government agencies, educational bodies, etc.

### 3. PRICE FOR EXHIBITORS WITH MIXED ACTIVITIES: €83/M2 (HORS TVA)

- Price excludes file charge for registration fee, administration and promotion costs: €155/m²
- > For stands with **increased visibility** (3 or 4 open sides and a depth of 8m = 'front stand'), a surcharge of €7.00/m² applies.

If your organisation offers paid services but is also active in advocacy work and/or uses volunteers, you may be eligible for the 'exhibitors with mixed activities' rate. Contact the exhibition secretaries for more information.

### 4. SMALL INFORMATION STAND: €650 (TVA INCLUSE)

- > Price includes file charge for registration fee, administration and promotion costs.
- > Do you want to register an organisation with no commercial activities, such as an interest group, user organisation, sports club, etc. and do you only need a small, 6m2 information stand? If so, one of our all-in stands is probably a good choice.
- > Only one stand can be rented per association

This price includes a lot of what you need: walls, carpet, electricity, cleaning, lighting, etc.

### **FLANDERS EXPO COSTS**

The following additional costs will be charged and invoiced by Easyfairs/Flanders Expo for all stands, with the exception of small information stands:

- > Electricity: minimum 1 x 16 A 3520 W
- > Third-party liability cover for the exhibitor and comprehensive insurance: minimum €100 (excluding VAT), up to €20,000. The comprehensive insurance premium depends on the value of the products. The exhibitor is obliged to submit a list of materials, stating their value.





















# Setting up your stand

You can set up your own stand, hire someone to do it or make use of Flanders Expo's services (invoiced by them)...

### MODULAR STAND SETUP: €77,5/M2

### OTHER OPTIONS FOR STAND SET-UP WITH FLANDERS EXPO / EASYFAIRS

The Easyfairs online order form lists the range of possible concepts other than the REVA modular stand. You may also hire additional equipment or furniture. They will make you an offer and invoice you directly afterwards.

## **Themes** at REVA2025

- > **REVActive.** True to tradition, we will be putting a theme in the spotlight at REVA. This time, we are turning extra attention to recreational exercise and G-sport **in partnership with G-sport Flanders**. For example, we have a wide range of sports demonstrations by various sports clubs. This theme is sure to appeal to many people and offers you an opportunity to reach a new audience.
- > At the same time, REVA2025 will once again present an extensive range of new resources, services, associations run by and for people with a disability, and so much more. So even if you have no connection to the field of G-sports, your contribution to REVA2025 is vital.
- > Ziezo Vlaanderen. Are your activities aimed at blind and visually impaired people? Do you offer assistance tools for this target group? Does your organisation represent blind and visually impaired people? If so, you can choose a stand position at Ziezo Vlaanderen. That makes it easier for blind and visually impaired people to find you.
- > **REVAcation village.** In the REVAcation village, you will find all the exhibitors who offer tourism opportunities. Do you offer products and services for tourists? If so, reserve your space in this zone.
- **Government village.** This is where you will find a cluster of different government bodies.

### **EVEN MORE EXTRAS**

Other important extras at REVA2025 include:

- > REVAhome in collaboration with HOGENT. At this stand, you will discover a vast array of small appliances for the kitchen, bathroom, home living, leisure, gardening, etc. Attend workshops and get free advice on home living. Do you have products or services in the 'home' and 'leisure' sectors? If so, you can discuss with the lecturers at HOGENT how to create a place for them at REVAhome.
- > REVAtalks with various testimonials and talks about sport and exercise, assistance tools, therapies, etc.

### **YOUR DEMO SESSION AT REVA2025**

You can also give a demo session for your customers and exhibition visitors at REVA2025. We provide a demonstration space at the exhibition which you can rent for a certain time in return for a fee. We announce these sessions in advance and you can advertise them yourself as well.



# A few practical and technical arrangements

Below you will find a selection of the exhibition regulations. For the full list of arrangements, please refer to the exhibition regulations on the website. This overview does not in any way replace the exhibition regulations.

### **REGISTRATION AND EXHIBITION INFORMATION**

- > Registration on the website is considered a binding contract.
- > Permission to set up the stand and effectively participate in the exhibition can only be granted following full payment of the invoice.
- > Before 24 nobember 2024, stand location options remain valid for 1 month. From 25 november to 24 maart 2025, options remain valid for 1 week. No further options can be taken after 25 maart.
- > Information on cancellation costs can be found in Chapter 5 of the exhibition regulations on the website.
- > Exhibitors wishing to share a stand must notify the secretary. They must register as separate exhibitors and are to be invoiced separately. In all other cases, you can only be listed as a separate exhibitor on the website and receive promotional material if the additional exhibitor pays the handling fee.
- It is forbidden to hand out samples or printed materials anywhere except on the stand. It is also forbidden in other public areas such as terraces, the entrance hall, corridors, toilets, car parks, etc.
- > For safety reasons, a speed limit of 5 km/h applies to all vehicles (bicycles, wheelchairs, scooters, etc.) in the corridors of the exhibition.
- > Exhibitors wishing to organise an attraction at their stand for an audience to watch must first ask permission from REVA, due to the possibility of disruption for other exhibitors. Be sure to also consider any possible costs charged by SABAM.
- > It is forbidden to place objects outside the perimeter of your hired space.
- > To a limited extent, exhibitors are permitted to sell products directly to visitors at their stands. Where applicable, there is a maximum unit price of €120, including VAT, and this price must be clearly visible.
- > Send your stand design to REVA vzw and Easyfairs at least one month before the start of the exhibition.
- If you are working with subcontractors, you need to fill in and return the form 'Certificate of waiver of recourse'. You will receive this form after registration.

### **STAND SET-UP**

- > Please note the location of nearby power sockets.
- > The walls adjacent to the corridors must be clear and accessible to the public.
- > All walls adjacent to a neighbour must reach a height of 2.5 metres.
- > These walls cannot be any higher or lower. You can only build higher if separated from your neighbour's wall by one metre, and only if the structure or advertisement is in no way obstructive to them. Transparent construction profiles on corners are an exception to this, but between the profiles, the walls should be no higher than 2.5 metres. Anyone wishing to build higher than 2.5 metres must apply to REVA and obtain approval from their immediate neighbours.
- > Every stand must be illuminated.
- > Flanders Expo/Easyfairs will make an online order form available where each exhibitor can order additional equipment and services (furniture, electricity, etc.). Flanders Expo/Easyfairs will provide the necessary information on how to access this form.

> 8.00 - 22.00: lorries permitted

### **WEDNESDAY 23 APRIL FOR ALL EXHIBITORS**

- > 8.00 14.00: lorries, cars and small vans permitted
- > 14.00 20.00: cars and small vans permitted
- > all stands must be set up by 20.00

Setting up before Tuesday 22 April is only possible if Easyfairs gives you permission to do so and on the condition that you pay the costs charged by Easyfairs.

### **EXHIBITION DAYS**

- > 08.30 18.00: open for exhibitors
- **> 09.30 17.00**: open to the public

### FRIDAY, 25 APRIL

- > 08.30 18.00: open for exhibitors

- > 09.30 17.00: open to the public

> 17.00 - 24.00: gates will not open until 17.20, once all visitors have left the hall.

By way of exception, you can still remove stand materials on Monday 11 December, subject to permission from Easyfairs and provided you pay for any additional hours of security and other costs charged by Easyfairs.
